Chapter 69, Animals, Section 69-6F(1) Impoundment fee from \$15.00 to the rate charged by the SPCA (Central New York Society for the Prevention of Cruelty to Animals) §69-6F(2) Boarding fee from \$7.50 per day to the rate charged by the SPCA (Central New York Society for the Prevention of Cruelty to Animals) to the Code of the Town of Clay.
